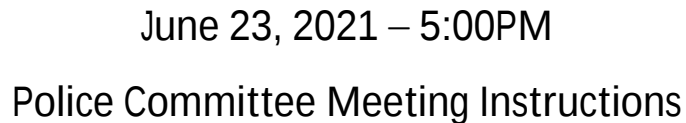

1. The meeting was called to order at 5:00 p.m.

2. **Minutes**
