1. The meeting was called to order at 5:01 p.m.

2. **E-Bicycle Patrol Program**

Chief Crowell introduced Officer Dan Carr and discussed the E-Bicycle program. Chief Crowell stated that the department received a \$2,000 donation from a generous resident and the funds from that donation were used to purchase the E-Bicycle. Chief Crowell and the committee thanked the resident who donated the funds.

Officer Carr explained how the E-Bicycle works and how the department uses the E-Bicycles.

3. **Minutes**

A motion was made by Member Champagne and seconded by Member McGrew to approve the minutes of April 28, 2021. The motion passed unanimously.

4. **Chiefs Report**

- Chief Crowell reported that there has been several thefts of cars in the Village of Manlius and the Village of Minoa.
- Chief Crowell stated that he is working through the new discovery requirements.
- The department has completed legal updates training.
- Clerk Lynn Rybinski is retiring. The Chief discussed the hiring process for a front office clerk.
- Chief Crowell stated that the department is dissolving the Special Investigation Unit. The department is creating a Community Support Unit that will have a new role following the mission of the Town of Manlius Police Department. The Chief discussed the hiring process for the new Community Unit.
- Chief Crowell discussed the legalization of Marijuana.
- Chief Crowell stated that he has received final word that the department has received Accreditation from CALEA.
